Subject: Responsibility charter in respect of Transmission App for Real Time Monitoring & Growth (Tarang) : Timely updation of data and its maintenance

The undersigned is directed to forward herewith the Responsibility charter in respect of timely updation of data and its maintenance for Tarang mobile app and web-portal.

2 Keeping in line with the "Digital India" initiative of Government of India, "TARANG" (Transmission App for Real Time Monitoring & Growth) Mobile App & Web Portal has been developed by REC Transmission Projects Company Limited (RECTPCL) under the over all guidance of CEA and Ministry of Power, Government of India. Introduction of the electronic platform shall enhance ease, accountability & transparency and would boost confidence of investors in power transmission sector.

3 On 17.08.2016, 'TARANG' Mobile App was launched by the Hon'ble Minister of State (IC) for Power, Coal, New & Renewable Energy and Mines.

4 It shall facilitate the progress monitoring of transmission systems on Pan India basis and shall also provide details of the prospective upcoming Pan-India Inter State & Intra State Transmission projects and show the status of delayed/stalled projects so that timely action can be taken by concerned authorities.

5 As the RECTPCL has developed the App and Web Portal, it shall also manage and maintain Tarang web/Mobile Platform and do the overall coordination with all stakeholders for timely updation of database of Tarang.

6 Further, It has been decided to fix the responsibility of all the stakeholders so that data be updated on regular basis and latest accurate data can be made available on the Tarang platform for use. All concerned are requested to take necessary action accordingly.
